Missoula Correctional Services, Inc was organized as a public benefit corporation to provide residential and non-residential programs for the care, treatment, and supervision of offenders who can be assisted to achieve a degree of responsibility that will enable them to live constructively in the community, to provide programs which make offenders accountable for their actions, and to provide programs which repay an offender's victims and community for his/her behavior This corporation is organized exclusively for charitable, scientific, and educational purposes, within the meaning of Section 501(c)(3) of the Internal Revenue Code

PRE-RELEASE CENTER AND TRANSITIONAL LIVING PROGRAM The mission of the Missoula Pre-release Center is to provide a structured community based residential program for adult offenders that holds an offender accountable while providing opportunities to the offender to become productive and law abiding The Pre-Release Center is a residential transitional facility for adult male and female inmates It served 336 offenders during the fiscal year Of these 48 were paroled, 94 were released on conditional release, 14 discharged their prison portion of their sentences, 52 were terminated from the program, 4 escaped and 4 were administratively transferred to another institution The remaining individuals continued in the program into the next fiscal year The Transitional Living Program is an extension of the Pre-Release Center that allows inmates to reside in private residences during their last 60 days It provides an additional transitional period to assist in their adjustment to independent living 83 offenders were in the Transitional Living Program during the fiscal year

MISDEMEANOR SUPERVISION PROGRAM The mission of the Misdemeanor Supervision Program is to provide a sentencing alternative to the Missoula County that reduces the likelihood of offenders committing more crimes by monitoring their compliance with sentencing conditions ordered by the Court The Misdemeanor Supervision Program monitors misdemeanor offenders for their adherence to court ordered treatment, compliance to behavioral restrictions such as the usage of alcohol or drugs, and contact with victims, intake of monitored antabuse, and the payment of fines The Misdemeanor Supervision Program received its first client July 1996 During this fiscal year the average daily population of offenders being supervised was 144 19 There were 265 offenders served during the fiscal year During the fiscal year 92 clients successfully completed their term of probation supervision An additional 37 were released from supervision by the Court in some fashion (revoked to jail, deceased, etc) The remaining individuals continued in the program into the next fiscal year

MUNICIPAL COURT MISDEMEANOR SUPERVISION PROGRAM In June 2012 Missoula Correctional Services, Inc began providing probation services to the Missoula Municipal Court The mission of the Municipal Court Misdemeanor Supervision Program is to provide a sentencing alternative to the Municipal Courts that reduces the likelihood of offenders committing more crimes by monitoring their compliance with sentencing conditions ordered by the Court During this fiscal year the average daily population of offenders being supervised was 190 03 There were 344 offenders served during the fiscal year During the fiscal year 110 clients successfully completed their term of probation supervision An additional 54 offenders were released from their supervision by the court in some fashion (revoked to jail, deceased, etc) The remaining individuals continued in the program into the next fiscal year
